

Year 7 Blackwell Court Education Trip 2019

Dear Parents/Carers,

We are writing about an exciting outdoor educational opportunity that we are offering to Year 7 pupils, during the week of 20th May, 2019.

We have booked Blackwell Court, Bromsgrove. This centre offers challenge and excitement in the form of activities such as abseiling, zip wiring, archery and many more. This is an extremely popular venue and offers great value for money.

There will be two groups going Monday to Wednesday afternoon and Wednesday afternoon to Friday so a 2 and-a-half day stay in duration. We have booked the Manor House which is an excellent accommodation with shared bathroom facilities for the pupils on each floor. There are 3 meals per day made by the activity centre catering staff with plenty of choice as well as water available all day.

The total cost will be approximately **£160** and will include everything for the 2 and a half day stay: transport to and from the centre, food and accommodation, insurance, tuition by qualified instructors, and use of equipment. There will be some reduction in the cost for any children eligible for free school meals.

The final price will be confirmed once we know the exact numbers of pupils going. After that payment can be made in instalments. You will be required to pay using the ParentPay system. If you have not yet registered to use ParentPay please contact the school office. All payments must be made by the deadlines otherwise your child's place will be offered to another child who is on the waiting list.

At the moment we are gauging interest in this residential trip, so please **do not send any money now**. If you would like your child to take part on this exciting trip, it is most important that you return the reply slip to Mr. Gripton by **Friday 11th January 2019**.
